

SECOND SUPPLEMENTARY APPROPRIATION ACT 1990WESTERN SAMOAArrangement of Provisions

Schedule

AN ACT to authorise the issue and application of additional sums of money out of the Treasury Fund to certain services of the year ending with the 31st day of December 1990 and to authorise the reduction of certain sums of money previously appropriated for certain services for that year.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. Short title - This Act may be cited as the Second Supplementary Appropriation Act 1990.
2. Application - Sections 3 and 4 and the Schedule of this Act relate to the year ending with the 31st day of December 1990 (herein referred to as "the year 1990").
3. Amendment to Appropriation Act 1990 - The Appropriation Act 1990 as amended by the Supplementary Appropriation Act 1990 is further amended by reducing the appropriations authorised pursuant to that Act by the sum of \$400,000 by effecting the reduction shown in column 2 of the second part of the Schedule to this Act.
4. Grant and appropriation of \$10,976,480 out of Treasury Fund - (1) There may be issued out of the Treasury Fund and applied to the services of the year 1990 in addition to the sums

appropriated for the year 1990 under the Appropriation Act 1990 as amended by the Supplementary Appropriation Act 1990 and as amended by section 3 of this Act the sum of \$10,976,480.00.

(2) The sum authorised to be applied by subsection (1) of this section is hereby appropriated to the services expressed in the votes specified in the first part and in column 3 of the second part of the Schedule to this Act.
