**NOTICE OF CHARGE ON BASE TARIFF FOR THE

I, TUISUGALETAUA SOFARA AVEAU, Minister responsible for the Electric Power Corporation, pursuant to section 23A of the Electric Power Corporation Act 1980 give notice that:

1. The charge to be applied on the base tariff charged for the supply of electricity is 13.59%.
2. The charge is to compensate for the cost of fuel used for the supply of electricity.
3. This Notice commences on 1 May 2010.
4. The Notice of Charge on Base Tariff for the Supply of Electricity (No.4) 2010 dated 23rd of March 2010 is revoked.
